**Notification:**

In partial modification of notification, No KIU-Acad-1(2)/2019/417017 dated: June 17, 2020 and in anticipatory approval of the KIU Syndicate and Senate the Academic Council in its 5<sup>th</sup> Online meeting held on June 15, 2020 has approved the General Policy of grant of 15% Fee Concession and payment of semester fee in easy installments of Spring Semester, 2020 (under Blended Learning/Education System) due to prevailing situation of COVID-19.

The general policy is as follows:

1. 15% fee concession of Spring Semester (under blended education system) may granted to all BS/B.Ed, Master/M.Ed/MBA those students who were registered on or before Fall Semester 2019 and payment of Spring Semester 2020 fee (under Blended Education/Learning System) in easily installments.
2. The recovery of outstanding fee of 2<sup>nd</sup> Semester of Masters Program students who registered in Spring semester 2019 may be decided later on and once response from the Federal Government/HEC is finally received.
3. Fee for Spring Semester 2020 (under blended education system) may either be paid in lump sum and 15% fee concession may be availed or may be paid in 3 easy installments and 15% may be availed in last installment as detailed below:
  - i. 40% of semester fee at the time of registration and before start of classes.
  - ii. 20% semester fee before end of July, 2020
  - iii. 25% of semester fee before end of August, 2020
  - iv. 15% of semester fee to be availed as fee concession
4. A copy of fee payment plan in easy installments is enclosed.

**General Policy of Grant of 15% Fee Concession and Payment of semester fee in Easy installments of Spring Semester, 2020 (Under Blended Learning / Education System)**

Due to prevailing of COVID-19 which has resulted into financial constraints for all over the world especially in less developed and less privileged areas, like Gilgit-Baltistan, in an online meeting held on 10<sup>th</sup> June, 2020 under the chair ship of the Vice Chancellor in which the Treasurer presented the financial review of the University from July 2019 to May 31, 2020, all Deans / heads of teaching departments recommended that as a general policy the students may be allowed to pay their fee in easy installments. After detail discussion, it was also agreed to place the case before Academic Council.

2. In an online meeting of Academic Council held on 15<sup>th</sup> June, 2020, the OAC recommended that as a general policy 15% fee concession of spring semester fee (under blended leaning system) may granted to all BS/B.Ed, Master/M.Ed/MBA those students who were registered on or before fall semester, 2019 and payment of spring semester 2020 fee (under Blended Education / Learning System) in easy installments.

3. The OAC also recommended that recovery of outstanding fee of 2<sup>nd</sup> semester of Master programs students who registered in spring 2019 may be decided later on and once response from the federal government / HEC is finally received.

4. The OAC recommended that as a general policy, Fee for spring semester, 2020 (Under Blended Learning System) may either be paid in lump sum and 15% fee concession may be availed or may be paid in 3 easy installments and 15% may be availed in last installment as detailed below:-

- i. 40% of semester fee at the time of registration and before start of classes.
- ii. 20% of semester fee before end of July, 2020
- iii. 25% of semester fee before end of Aug, 2020
- iv. 15% of semester fee to be availed as fee concession.

5. A copy of fee payment plan in easy installments is also enclosed.

The above recommendations may be approved for notification and in anticipation approval of the Syndicate / Senate KIU please.
